Please expect new medical cards prior to July 1 and start using Moosilauke Visions as your company name when asked for it by providers.

## Open Enrollment (OE) Is Wednesday, May 15 through Wednesday, May 29 for benefits effective July 1, 2024 through June 30, 2025.

### What is annual open enrollment?

Annual Open Enrollment is the time when you will have the opportunity to:

- Enroll or Waive 2024/2025 benefits
- Change or Cancel your coverage
- Add or Remove Dependents

### This is a passive enrollment!

If you do not wish to make any changes to your benefits, your elections will roll over into the 2024-25 plan year, with the exception of the Health, Dependent Care, or Limited Purpose FSA and Voluntary Family AD&D coverage. If you wish to participate in the FSAs, you MUST take action and enroll during open enrollment. Family AD&D coverage is being discontinued effective July 1, 2024. It has been replaced with the option to enroll in spouse or child AD&D coverage. If you want your dependents covered you must re-enroll them.

# What's new for 2024/2025 plan year?

## Benefits Website - mymvabenefits.com

Our benefits website will be your one-stop-shop for everything related to benefits. We will be updating the site with more information as we get closer to open enrollment.

## Medical Plan Changes

 The most expensive tier for medical coverage has been removed for the 2024/2025 plan year. Starting July 1, there will be two tiers: less than two years and 2+ years of service.

Note: Please see the open enrollment guide for updated medical contributions.

# **Dental Plan Changes**

- Moosilauke Visions and Affiliates has moved from three to four tiers of coverage: Employee, Employee & Spouse, Employee & Child(ren), and Family. These are the same tiers as the medical and vision plans.
- Years of service tiers have been removed from the dental plans

## Additional Benefit Changes

- The amount of life insurance and AD&D coverage provided at no cost is increasing to 1x your base pay, up to a maximum of \$200,000.
- You have a one-time opportunity during open enrollment to enroll in voluntary employee and spouse life insurance, up to \$150,000 for employee and \$50,000 for a spouse, with no medical underwriting required.
- Voluntary Family AD&D is being removed and replaced with spouse and child(ren) AD&D options. Be sure to review the new options if you previously enrolled in Family AD&D.
- Pet Insurance is now available through MetLife. To get a quote, go to metlife.com/getapetquote. If enrolled, you will be billed directly by MetLife.
